Dear Chairman VanMeter;

It is an honor to present to you and the County Board the 2017 Sangamon County Sheriff's Office Annual Report. Unfortunately, we were unable to provide you with the 2016 annual report.

As has been the tradition of Sangamon County Government, the Sheriff's Office has maintained the highest level of service to the taxpayers of our county in the most cost-effective manner possible.

It is my pleasure to highlight some of the achievements in the Sheriff's Office since our last annual report.

- **February 2016 we changed the process of disposing of vehicles and started sending them to be auctioned off**- greatly increasing revenue per vehicle and more than \$93,000.00 in total auctioned revenue
- **May 2016 we changed the inmate phone vendor in the jail**- increasing our revenue by almost \$11,515.00 per month on average
- **December 2016 we installed a Video Visitation system in the jail- increasing efficiency and safety in the jail**- reducing the amount of overtime required for visitations; system completely paid off within the first 12 months of revenue from the new phone vendor
- **FY 2016 started program to fully equip all patrol vehicles with new radar units, video system, and new mobile computers**
- **Purchased 13 Ballistic vests for correctional officers** - increasing safety during inmate transports
- **Purchased 76 Level 3 Ballistic vests**- increasing safety for deputies
- **Purchased 50 rifles for the Merit Deputies**- increasing safety
- **January 2017 we implemented 24 hour medical coverage in the jail**- increasing the coverage as a result of the increase in revenue from the new phone vendor
- **March 2017 we reopened the Crime Prevention Division**

- **March 2017 we eliminated the Civilian Civil Process Division and assigned the responsibilities of the civil process and eviction process to the Patrol Division- increasing services and efficiency**
- **June 2017 we implemented the requirement of new civilian employees to complete the Behavior & Abilities Assessment tool**
- **Added two additional Merit Deputy Positions to increase the manpower in the Patrol Division to assist with Civil Process**
- **February 2018 we implemented the Mental Health coverage to 40 hours a week- increasing the coverage as a result of the increase in revenue from the new phone vendor**
- **March 2018 the Sangamon County Jail was certified as PREA compliant. PREA is Prison Rape Elimination Act and is Federally Mandated certification for correctional facilities-** the corrections staff worked for over a year to create, and implement the policy, procedures, and requirements to pass the PREA audit
- **April 2018 the Sangamon County Auditor's Office assisted the Sheriff's Office with conducting a complete and thorough audit of all Sheriff's Office inventory and assets-** provides an up to date- accurate inventory of all assets
- **FY 2018 started program to replace all jail radios**
- **Replaced all old Tasers with new Tasers**

In addition to the above, in September of 2017 we entered into a Memorandum of Understanding with the Gateway Foundation to provide help to inmates battling the heroin and opiate addiction. Gateway was provided with an office in the jail and provides drug addiction counseling. They also offer inmates, prior to being released, the Vivitrol shot. VIVITROL is a non-addictive, once-monthly treatment proven to prevent relapse in opioid dependent patients when used with counseling following detoxification. VIVITROL blocks opioid receptors in the brain while they work with the psychological aspects of counseling. Below is information from the beginning of the program to date (April 2018).

- 235 inmates completed referrals to be placed into the program. Most are awaiting release dates to begin the medicated assistance protocol.
- 60 offenders have received the Vivitrol shot
- 57 have actively attended substance abuse treatment
- 33 of the 60 have been discharged for not engaging in all required services
- 25 of the 60 have taken their second Vivitrol shot
- 15 of the 60 have taken their third Vivitrol shot
- 8 of the 60 have taken their fourth Vivitrol shot
- 5 of the 60 have taken their fifth Vivitrol shot
- 2 of the 60 have taken their sixth Vivitrol shot
- 1 of the 60 have taken their seventh Vivitrol shot
- 3 have completed the Jail MAT program- meaning they have secured housing, employment and completed out-patient services

According to Gateway, the Sangamon County Sheriff's Office is one of the most successful programs in the United State.

I am proud to say all of these accomplishments have been achieved with no additional budgeted cost to the taxpayers of Sangamon County. In fact, the Sheriff's Office has been under budget for three consecutive years.

We are committed to continue to build on our strengths and to improve in areas that can better serve county taxpayers.

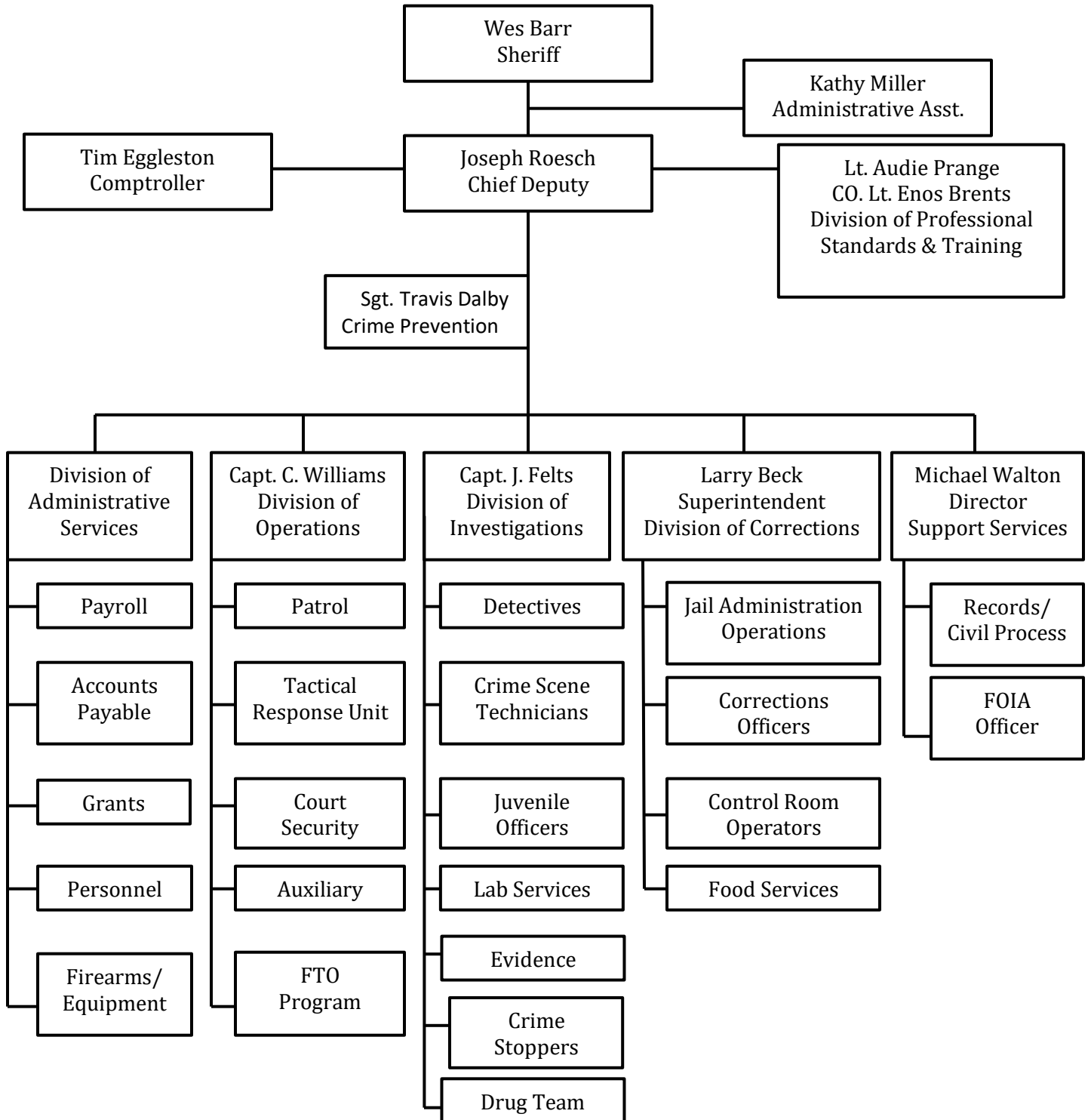
With this being my last annual report as Sheriff of Sangamon County, I want to thank you and the County Board for your support of the Sheriff's Office.

2017 was a very successful year thanks to the hard work and integrity of the Sheriff's Office Employees. Over the last three years, Sheriff Barr has fostered a fair, firm, consistent, and disciplined work environment. As a result, there has been a very drastic reduction in serious discipline cases including sick leave abuse. Our employees are extremely professional and conscientious and do an exceptional job in all of their respective duties. The administration is very proud of our employees and the difficult and dangerous work they do every day.

Over the last three years, the Sheriff's Office has made great improvements in many areas. The Corrections Division has implemented an improved field training program that is working very well. The Patrol Division has also made positive changes to their field training program, and the updated program will be implemented this summer with two probationary deputies starting their field training program. The Sheriff's Office has reinstated the Crime Prevention Division, led by Sgt. Travis Dalby. Sgt. Dalby has done a great job implementing community programs and improving valuable public relations with the citizens of Sangamon County.

Sheriff Barr's administrative staff includes Chief Deputy Joe Roesch, Captain Cheryllynn Williams, Captain Jerry Felts, Jail Superintendent Larry Beck, Professional Standards Lt. Audie Prange, Professional Standards Lt. Enos Brents, Sgt. Travis Dalby, Court Security Lt. Jerry Durr, Director of Records Mike Walton, Deputy Jeff VanHoos, Kathy Miller, Chrissie Wheeler, Betty England, and Crystal Chalmers.

**PERSONNEL**

Kathy Miller, Betty England, and Chrissie Wheeler comprise the clerical staff of the Administration Division.

Kathy Miller oversees the daily operations of the office. She is not only the Sheriff's Administrative Assistant, but provides clerical assistance to the Chief Deputy

and Captain of Operations. She also supervises the daily activities and training of the Accounting Tech and Personnel Assistant. Countless questions and requests from not only staff and co-workers, but public, private, and government sects are handled at her desk daily. Inquires through the Sheriff's website are received by Kathy who processes the information directly or forwards them to the appropriate Division.

Betty England has been the Accounting Tech for the Sheriff's Office since 1998, processing invoices for approval by the Jail Committee twice a month, processes Accounts Receivable, and generates daily reports for the Treasurer's Office. In addition, she ensures all needed files and documents are organized and ready for the outside auditor's annual inspection.

In September 2017 Chrissie Wheeler was hired as the Administration Division's Personnel Assistant. Although she is new to the Administration, she is not new to the Sheriff's Office, serving as a Records Clerk for 3 years before this career change. As Personnel Assistant Chrissie maintains applications for employment and auxiliary deputies, conducts new employee orientations, processes worker's compensation claims, and employee time and payroll records.

These three women generate a tremendous amount of work in an efficient and professional manner, providing assistance to not only the 200+ employees of the Sangamon County Sheriff's Office, but to all citizens of Sangamon County with whom they have had contact.

**FLEET AND EQUIPMENT MANAGEMENT**

**Deputy Jeff VanHoos**

Deputy VanHoos is responsible for the purchasing and distribution of departmental weapons, equipment and the ordering of all vehicles. He is also responsible for overseeing the maintenance of said equipment and vehicles.

Terri Motley was assigned as the Purchasing Assistant in late 2016. Her duties included research, getting bids, purchasing, ordering and issuing of officer supply needs such as uniforms, equipment and office supplies. She has also assumed the reviewing and maintenance of the cellphones and the WEX fuel accounts as well as any other necessities that come along. 2017 saw Terri transfer back to the Records Division as the Assistant Director. The Purchasing Assistant position was not refilled in 2017 so Deputy VanHoos assumed all of those duties along with his normal Fleet/Equipment Management duty.

In 2017, this section processed 164 new uniform orders, 89 separate office supply orders along with issuing out 279 cases of copy paper.

2017 saw the purchase of nine (9) new vehicles for the sheriff's department. Four (4) went to the patrol division, three (3) went to the Investigation division and two (2) went to the administration division.

Deputy VanHoos also oversaw the purchase of seventy-six (76) active shooter vests for the patrol, investigations, court security and administration divisions, thirteen (13) stab proof vests for corrections division and seven (7) new personal body armor vests for deputies.

The firearms unit conducted 35 range dates in 2017. 13 days were dedicated to in-service training where Deputies, Correctional officers, and court security qualified in their annual firearms training.

11 days were dedicated to patrol rifle qualifications. The firearms unit ran 3 back to back (2) day patrol rifle classes. This class is a state certified class for Deputies that have not had any formal patrol rifle training to become familiar with the weapon system and get qualified.

The department currently has (52) Deputies issued and qualified to carry patrol rifles.

The department also traded its old Glock 22 (.40 caliber) pistols and opted to carry the Glock 17 (9mm caliber) pistol. This pistol allows the Deputies to carry (6) additional rounds compared to their old weapon system.

In 2017, 66 deputies, 69 Correctional officers, 13 court security officers, 12 sheriff's auxiliary, and 13 tactical response unit members, went through annual firearms training. 8 new correctional officers went through the mandatory 40 hour firearms training

program. Also, in June, 34 retired Deputy Sheriffs attended annual training and have completed the requirements set forth by the sheriff's office.

Weapons repaired in 2017 were as follows:

- 36- Remington 870 inspections/upgrades
- 4- 40 mm less lethal inspection
- 16- Less lethal shotgun inspections

**OPERATIONS DIVISION**  
**Captain Cheryllynn Williams**

In 2017, there were 41,344, incidents in Sangamon County where deputies either initiated a law enforcement service or were dispatched to a call.

There was a lot of movement in the operations division in 2017. In April, Will Brooks, Jordan Cox, and Ryan Kuntzi were hired as a Sangamon County Deputies. Deputy Brooks began the Field Training Program immediately due to prior law enforcement training, and Deputies Cox and Kuntzi began the Illinois State Police Recruit Class. Sergeant Andy Danes was transferred from second shift to the Investigations Division in August. Detective Nancy Finley was promoted to Sergeant and transferred to second shift. Deputy Travis Dalby was transferred from second shift to Crime Prevention in March. Deputy Andrew Brashear was transferred from first shift to the Investigations Division in November.

In June, Deputy Knox retired after 25 years of service. His humor and kindness will be missed.

**TACTICAL RESPONSE UNIT**  
**Lieutenant John Hayes, Commander**

The Tactical Response Unit, also referred to as the “TRU”, was implemented in 1975. Currently the Unit consists of 18 sworn members and 2 tactical medics. The Unit is commanded by Lieutenant John Hayes and Sergeant Jim Tapscott. The TRU is a support resource within the Sheriff’s Office. Members of the TRU are also a part of the City/County Weapons of Mass Destruction Special Response Team. This joint team may respond anywhere in Illinois in the event of a terrorist attack or natural disaster. The TRU is also a multijurisdictional team, with Officers from the Sherman and Chatham Police Departments. The TRU is charged with various assignments; inclusive of executing high risk search, securing and resolving barricaded/hostage situations, VIP dignitary protection, crowd control, security at large scale natural or manmade disasters, and any situation where a tactical unit may be needed. Members of the TRU are trained in security, sniper/observer, stealth and dynamic entry, including explosive breaching and hostage rescue situations.

Members of the TRU train at least once a month, and members of the City/ County Weapons of Mass Destruction Team train an additional day per month. TRU members, depending on their assignment, may attend a variety of specialty schools each year. All TRU members are on call 24 hours a day, and can be called at a moment’s notice.

### **K-9 UNIT**

#### **Sgt. Anthony Mayfield, Supervisor**

Since 2015, the K-9 Unit has gone from three teams down to one. With the retirement of Deputy Stapleton's K-9 "Zaso" due to age and the retirement of Deputy Cline's K-9 "Nika" due to health, Deputy Drew Dickason and his K-9 "Rajah" are currently the only working team at the Sheriff's Office.

Deputy Dickason and "Rajah" have managed to keep up with the demand of community demonstrations, school searches, and patrol functions that were once accomplished

with 3 teams. This is direct result of Deputy Dickason's hard work and commitment to being a K-9 handler.

Deputy Dickason and "Rajah" continue to certify with The United States Police Canine Association (USPCA) in the areas of narcotics, criminal apprehension, agility, obedience, and article and suspect searches.

For better patrol coverage, Deputy Dickason and "Rajah" were moved to a power shift in 2018. A future goal is to add one more team to the unit to have overlapping coverage on the power shift.

### **COURT SECURITY** **Court Security Lieutenant Jerry Durr**

Court Security personnel are charged with the responsibility of protecting the entire court complex facility. Their duties include screening enters the building, as well as their packages/cases; securing the halls, offices, courtrooms and providing personal protection for judges, elected officials, attorneys, county employees and all other persons within the building. These personnel are trained in various aspects of security and law enforcement, inclusive of explosive recognition and detection, crowd control and arrest/apprehension techniques. A staff of four part-time bailiffs assists with daily court operations and trials as well. In addition, the unit is responsible for transporting and securing juveniles from the detention facility to court and at times to state facilities.

In 2017, the Court Security Division mad 612 arrests, and transported 755 juveniles to Court from the Detention Center and juveniles to the Department of Corrections. Court Security also served 229 civil papers.

## **HONOR GUARD**

### **Court Security Officer Barbara Krueger, Unit Coordinator**

2017 has been a very active year for the SCSO Honor Guard. We have had several flag postings and Funeral details. Illinois has sadly had too many Full Honor Funerals these past few years, and 2017 wasn't any different. We attended many Death in the Line of Duty funerals from Chicago to Chester, Illinois.

Most of our details are last minute. We all scramble our work and personal schedules to make sure all the details are covered. Sometimes we will have members do an early portion of a funeral (wake) detail, while another member can come for the later portion. It is inspiring to be a member of a unit, where everyone tries to "do more". Often if an officer cannot stay for the entire evening of a wake, the members who have to leave early, willingly take the first several postings at the casket, so the others that stay all evening will not be constantly taking turns until the late shift arrive. Very common, we work around every one's work schedules as well. We are truly an elite group.

We had another gun raffle with breakfast/Easter Egg Hunt. It was our (off year) to pass on going to Washington D.C., so we saved our money, for 2018. We have been very blessed by the Sheriff to continue to let us have the gun raffle. It works out really well for us. All of our fundraising money goes towards replacing items such as: broken eagles on flags, white gloves, new braids, and of course, our hotels every other year in Washington D.C. In 2017, we are trying to order leather coats for everyone. This will be nice when everyone has a coat, so we can wear coats for the winter details.

The most work we do is behind the scenes. We wash and wax vehicles before each funeral, we steam flags before parades, we buy tickets for our raffles on line, and of we all enjoy cooking the Breakfast fundraiser at Aqua Club. We have made the Aqua Club our home away from home; with meetings, practices and fundraisers. The Aqua Club lets us go there, on last minute notice, so we can practice for full honor funerals. We practice folding the flag in their big room. Our practices are on Saturday mornings. We found that (even thou we would much rather sleep in on Saturday Mornings) it is easier to have meetings on Saturday mornings, with members from 3 shifts plus one from the Detective Bureau.



The SCSO Honor Guard Unit is strictly a volunteer Unit. Some days we are on the road for a full honor funeral from 4am to 1am the next day, and it is all volunteer. Members attend the funerals as long as it does not cause any overtime or hire back.

We are returning to Washington D.C. May 2018 for the National Police Memorial, and we have a few surprises planned for 2019.

When we are attending a full Honor funeral, it is not unusual to be asked to help run last minute errands or step up and help post for the home agency, and we will NEVER say no to a host agency in morning. We call ourselves and Honor Guard instead of Color Guard. The main reason for our existence is to Honor our Brothers and Sisters that have fallen in the line of duty. We also realize that we represent not only our department but also our professions. ### **TACTICAL NEGOTIATIONS** **Sgt. Jason Boesdorfer, Unit Commander**

In 2017, The Tactical Negotiations Team continued our monthly training in preparation for critical incidents that involve barricaded or hostage situations or people in crisis. We participated in joint field training exercises with Sangamon County Sheriff's Office Tactical Response Unit.

On 09-01-17, Sangamon County Deputies were sent to a check on the welfare at 11050 Carson Road in Waverly. A female called in to report her husband was tying a noose in

the outbuilding on their property. After calling 911, the husband came back in the house and got a gun case that contained a .40 caliber pistol. TRU and HNT were activated and sent to the scene. Prior to arrival, the subject fled the area on foot. HNT attempted phone contact several times unsuccessfully. The subject was later apprehended in the area on foot.

On 11-26-17, Sangamon County Deputies were also sent to a check on the welfare of a 10 month old. The baby's father was concerned that the baby's mother had the baby at 2717 S. Glenwood with a fugitive who was selling drugs. The fugitive was said to be Arthur Campbell. Patrol deputies knocked on the door and Campbell opened the door. Upon seeing them, he slammed the door and ran back in the house. A perimeter was established and TRU and HNT were activated. A search warrant was obtained for the premises. While waiting for the search warrant, the mother and baby exited the residence. Two other males also exited the premises along with 2 handguns. Prior to TRU executing the no knock search warrant, Sgt. Wooden and Sgt. Boesdorfer utilized the suspect's girlfriend to successfully talk him out of the house without incident.

On 12-16-17, Sangamon County Deputies were also sent to a check on the welfare of a male outside of 16 Arthur Jones in New Berlin that he was going to kill everyone. The male was acting erratically saying he works with the CIA and FBI. Patrol formed a perimeter around the house and could see JD Schoonover inside the house with a shotgun on his shoulder. HNT members working at the time responded. Deputy Hanson made cell phone contact with the suspect and after 30 minutes, negotiated a peaceful surrender.

### **AUXILIARY**

#### **Sgt. Travis Dalby, Auxiliary Liaison**

The Sangamon County Sheriff's Office Auxiliary is a volunteer organization, which maintains approximately 20 non-sworn members. While "on duty" they carry the same authority as a Merit Deputy. The Auxiliary personnel function as a valuable, well-trained addition to sworn personnel. They assist in numerous functions such as patrol procedures, event security, responding to disaster scenes, and assist in special operations such as roadside safety checks, drug collections at Department of Health, and volunteer to add additional uniformed bodies for special events. Prior to accompanying deputies on patrol, every member must complete training in the use of deadly force and firearms proficiency, followed by continual training in communication procedures, domestic disturbance response, traffic stops, search/seizure and any other legal aspect of law enforcement which they may encounter. Virtually all members have

other full time employment, and volunteer their time and talents to the Sheriff's Office on a regular basis.

The Support Services Division of the Sangamon County Sheriff's Office consists of the Records Section, Civil Process and administration of the Freedom of Information Act. In 2017 Sheriff Barr recognized the need for an Assistant Director of the Support Services Division and longtime Team Member, Mrs. Terri Lyn Motley was selected to fill that position.

The Records Section personnel are responsible for:

**Case Files:** The receipt, merge, distribution, classification, data input, filing and storage of all offense, traffic crash and follow up reports.

**Freedom of Information Act:** On January 1, 2010, the Illinois Legislature completely revamped the Illinois Freedom of Information Act which caused additional personnel hours and resources to comply with this unfunded mandate. In addition to current FOIA Officers Director Walton, Assistant Director Mrs. Terri Lyn Motley and Ms. Stacey D. Garoutte we are fortunate to have Assistant States Attorney Mr. Joel Benoit certified as a Freedom of Information Officer for Sangamon County. He has been of invaluable assistance to all of us here at the Sangamon County Sheriff's Office. In 2017, we handled **1,788 Freedom of Information requests.**

**Warrants, Orders of Protection and Civil No Contact Orders:** These documents are received from the Circuit Clerk's Office/State's Attorney's Office or other court jurisdictions. Upon completion of all data entry they are forwarded to the Sangamon County Sheriff's Office Patrol Division for service.

**Traffic Citations:** Upon receipt of all traffic citations, entry is made into our data entry system and then forwarded to the Circuit Clerk's Office. Citations/Traffic Stops that meet the criteria are also reported to the Illinois Department of Transportation for Racial Profiling.

**Traffic Crash Reports:** Information from traffic crash reports is also placed in the data entry system. Paper copies have always been available to citizens and insurance companies from the Records Section for a fee. The public has the option of purchasing copies of Sangamon County Sheriff's Office Traffic Crash Reports on line from [buycrash.com](http://buycrash.com)

**Out-Files/Arrest Jackets:** These files are received on a daily basis from the Jail and contain data compiled during the booking process and the duration of time the individual was incarcerated in the Sangamon County Jail. Duplicate data is removed and shredded, while other data is transferred to the individual's electronic arrest jacket in the computer system.

**2017 Total: Out-Files processed - 9,124**

**Other Regular Duties:** Insurance requests, criminal history checks, telephones, assist citizens at the counter, assisting all law enforcement agencies on a daily basis, mandated state reporting requirements, compile statistics, process expungement and sealing orders, file destruction and retrieving items from the data imaging system. Pursuant to the Child Sex Offender Notification law, four (4) times a

year, we mail out the Sangamon County Sex Offender list notification to approximately 400 schools, daycare and library facilities located in Sangamon County.

**CIVIL PROCESS**

The Sangamon County Sheriff’s Office now has sworn Deputies serving process.

**Civil Process:** When the Civil Papers are received they are placed into our data entry system and then forwarded to the sworn Deputies for delivery/service.

**Sheriff’s Sales:** Sheriff’s Sales are conducted every Tuesday at 9 a.m. in the Sangamon County Board Room by the Director or Assistant Director of Support Services. The County receives between \$75.00 and \$600.00 for each sale conducted. Between January 1, 2017 and December 31, 2017, 228 Sheriff Sales were conducted which generated over \$136,800.00 into Sangamon County.

The Corrections Division serves to maintain the care, custody and control of the persons incarcerated in the Sangamon County Jail. The division is divided into three shifts consisting of Correctional Officers, Control Room Operators, and Booking Clerks as well as Jail Administration, Court Officers, medical and nursing staff, kitchen staff and dock personnel. As the only adult holding facility in Sangamon County we receive and house all persons arrested by all police agencies located in Sangamon County, including but not limited to the Sangamon County Sheriff's Office, Springfield Police Department, Illinois State Police and the local municipal police agencies. We also hold (for a fee) federal prisoners from the U.S. Marshal's Service, the Federal Bureau of Prisons and U.S. Immigration Service.

In addition to providing correctional services, the Corrections Division is also involved in basic correctional officer training. In 1995, the Corrections Division of the Sangamon County Sheriff's Office entered into an agreement with the Police Training Institute at the University of Illinois (Champaign) to be a satellite training facility for basic correctional officer recruits. We now offer at least three (3) five-week State Certification Basic Correctional Officers Training Courses a year. Each course accommodates up to 42 Correctional Officer recruits from counties throughout the State of Illinois.

Over the last year, the Corrections Division was able to implement 24 hour medical services for inmates and increased our mental health services for inmates to 40 hours a week, up from 28 hours previously.

Since the last report, the detention facility has also implemented a new inmate phone service, video visitation, and a 24-hour kiosk for deposits to inmate accounts.

**Investigations Division**  
**Captain Jerry Felts**

By the end of 2017, the Investigations Division consisted of four supervisors, nine detectives, and one civilian to work over 460 cases and other assigned duties. The breakdown of the detective and civilian assignments in 2017 were as follows;

- Six detectives were assigned to general crimes which consisted of anything from death investigations, sexual assaults, robberies, burglaries, theft, etc., and assisted the drug unit (DIRT) on surveillances and search warrants. Two of those six detectives were also assigned to work more than 50 child sexual abuse cases through the Child Advocacy Center.
- One supervisor and a detective were assigned to oversee the evidence vault and conduct a full audit of its contents, process crime scenes, handle all evidence to and from the crime lab, and handle forfeitures.

- One detective is assigned to maintain approximately 126 sex offenders and 12 violent offenders against youth which consisted of registrations, violations, and verifications. The same detective was also assigned general cases.
- Two detectives were assigned primarily to the Drug Interdiction Response Team (DIRT) and were responsible for the handling over 110 drug investigations, drug related search warrants, informants, and buy/busts.
- One civilian was assigned to Crimestoppers to handle the secretarial duties for the office, which included the reception of tips from the public, facilitate payouts, arrange and facilitate board meetings and fundraising.

In 2017, the detective bureau went through the following changes; Jennifer Davis resigned her position as the Civilian Evidence Technician to work for a family owned business, Devyn Flanagan had a child and resigned as the secretary to be a stay at home mom, Detective Karhliker retired, Janet Edwards retired, Amy Williams was hired, Detective Ealey was promoted to Sergeant and was reassigned to the patrol division, Deputy Brashear was transferred to the investigations division, and Sergeant Danes transferred back to the investigations division to supervise crime scenes and take over the evidence vault.
